Lewiston Consolidated Schools School Board Meeting Minutes December 19, 2016

A regular meeting of the Lewiston School Board District 69 was held on Monday, December 19th, at 7:00 p.m. This meeting was open to the public and preceded in notice as required by law. The meeting was called to order and the Open Meetings Law acknowledged by President Terry Howell. Roll call found the following members to be present: Anderson, Howell, Little, Rule, Schuster, Woofter. Also present: Rick Kentfield, Fred Ivey, Linda Thomas, and nine visitors.

Rick Kentfield, Superintendent, presented the State Fire Marshal's report.

Fred Ivey, Principal, reported on junior high girls basketball, upcoming varsity girls and boys basketball games, late grade policy revision, and after school study hall program.

Rick Kentfield, Superintendent, updated the board on sharing extracurricular activities with Sterling and Pawnee City Schools, rental property, and student work release program.

Mr. Kentfield presented awards and expressed appreciation to Terry Howell for his 5 years of service and Neil Woofter for his 8 years of service as board members to the Lewiston Consolidated Schools. There were no board report committee reports at this time.
