Discussion was held on early graduation board policy requirements. Tabled to the November board meeting.

Rick Kentfield gave an update on board policy review.

Rick Kentfield, Superintendent, reported on band uniform proposal. Allison West explained proposal and answered questions. Mr. Kentfield also shared information on a heating and cooling system summary from Engineering Technologies, Inc., NCF board member letter, Lewiston Village Board notice, upcoming State Education Conference, advertising for full time bus driver, special education programming, negotiation timelines, Veteran's Day program, and board policy review.
