## STARTING SCHOOL UPDATE

What will school look like in the Fall? School administration continues to receive guidance from the Nebraska Department of Education and Southeast Health District on options for students returning to school. Guidance for planning and preparation for the new school year and how we will deal with transportation, instruction, special education, class size, food services, custodial health safety, activities, personnel, and calendar logistics is ongoing.

The COVID pandemic continues to evolve; once a plan of action for starting the new year is put into place and approved by the Nebraska Department of Education, Southeast Health District, and Lewiston Board of Education, you will be notified.

## **Attention Parents/Guardians, Former Students**

This is a notification to inform parents/guardians and former students of Lewiston Consolidated School District's intent to destroy Special Education records of those students who have graduated in the year of 2015 or earlier. After five years of graduation, these records are no longer useful to the district. Still, they may be useful to the parent/guardian or former student in applying for Social Security benefits, rehabilitation services, college entrance, etc. The parent/guardian or former student may request their records by contacting the Lewiston Consolidated School at 402-865-4675 by August 1, 2020

School Board Meeting Minutes  
June 15, 2020**

A regular meeting of the Lewiston School Board District 69 was held on Monday, June 15th, at 7:00 p.m. This meeting was open to the public and preceded in notice as required by law. The meeting was called to order by President Aaron Rule and he verbally acknowledged the Open Meetings Law poster and that the meeting was electronically recorded. Roll call found the following members to be present: Husa, Janssen, Rule, Schuster, and Searcey. Excused Absence: Sisco. Also present: Rick Kentfield, Juli Smith, and several visitors.

The agenda was reviewed. Moved by Schuster and seconded by Searcey “to approve the agenda as presented.” Those voting in favor of said motion: Janssen, Rule, Schuster, Searcey, and Husa. Those opposed: none. Motion carried, 5-0.

Visitors were welcomed. Visitor comments were made regarding the splitting of the 1<sup>st</sup> grade class and what the school is doing to address COVID-19 issues.

Moved by Janssen and seconded by Searcey “to approve the May 12<sup>th</sup>, 2020 meeting minutes as presented.” Those voting in favor of said motion: Rule, Schuster, Searcey, Husa, and Janssen. Those opposed: none. Motion carried, 5-0. Andrew Sisco joined the meeting at 7:08 P.M.

The treasurer’s report was presented by Steve Janssen, and Rick Kentfield presented the monthly claims, payroll, and transfers. Discussion was held. Moved by Husa and seconded by Schuster “to approve the June treasurer’s report, June payroll and claims as presented in the amount of \$241,796.25.” Those voting in favor of said motion: Schuster, Searcey, Sisco, Husa, Janssen, and Rule. Those opposed: none. Motion carried, 6-0.

Moved by Searcey and seconded by Janssen “to approve the resignation of Robert Loshbaugh.” Those voting in favor of said motion: Searcey, Sisco, Husa, Janssen, Rule, and Schuster. Those opposed: none. Motion carried, 6-0.

Moved by Schuster and seconded by Husa “to approve the 2020-2021 contract as presented for Joe Cox as Director of Buildings and Grounds.” Those voting in favor of said motion: Sisco, Husa, Janssen, Rule, Schuster, and Searcey. Those opposed: none. Motion carried, 6-0.

Moved by Husa and seconded by Schuster “to approve the 2020-2021 Technology Coordinator contract for Tim Lucas as presented with an annual salary of \$44,220.” Those voting in favor of said motion: Husa, Janssen, Rule, Schuster, Searcey, and Sisco. Those opposed: none. Motion carried, 6-0.

Moved by Searcey and seconded by Husa “to approve the Architectural Services Agreement as presented by Fakler Architects.” Those voting in favor of said motion: Janssen, Rule, Schuster, Searcey, Sisco, and Husa. Those opposed: none. Motion carried, 6-0.

Moved by Searcey and seconded by Sisco “to approve the quote submitted by Blue Valley Door for purchase and installation of two overhead security doors between the kitchen and cafeteria in the amount of \$6,325.” Those voting in favor of said motion: Rule, Schuster, Searcey, Sisco, Husa, and Janssen. Those opposed: none. Motion carried, 6-0

Rick Kentfield, Superintendent, updated the board on facility projects. No action was taken.

The Board will be conducting the Superintendent’s evaluation to be completed electronically prior to the July board meeting. The Superintendent’s annual goals were distributed and reviewed. President Rule informed Mr. Kentfield the district would reimburse him for the \$1,800 cost of completing the University of Cornell’s Conflict Management Certification Program.

Mrs. Smith, Principal, reported on MTSS training, registration, and summer activities.

Rick Kentfield, Superintendent, shared information about graduation, the English position, re-opening plans, teacher recruitment, and reviewed district reserves. It was decided the Lewiston Marching Band would not be attending the State Fair this year.

Board Committee report – No reports at this time.

Moved by Janssen and seconded by Sisco “to adjourn at 8:54 p.m.” Those voting in favor of said motion: Husa, Janssen, Rule, Schuster, Searcey, and Sisco. Those opposed: none. Motion carried, 6-0.

Next regular school board meeting will be Monday, July 13th, at 7:00 p.m.

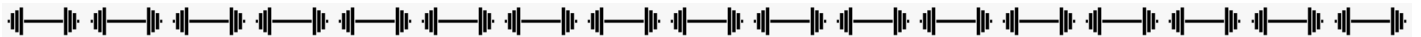
